## Judge Jeanine Pirro

Jeanine Pirro currently hosts “Justice with Judge Jeanine” and also serves as a legal analyst on the FOX News Channel. Judge Pirro’s notable legal career spans over 30 years. In 1975, she became an assistant district attorney for Westchester County, New York and was the first female to prosecute murder cases there. In 1990, Pirro was elected as the first woman to serve as a Westchester County Court judge.

In addition, Pirro started the first domestic violence unit in a prosecutor’s office in the country. In 1997, she was appointed by then-Governor George Pataki to chair the New York State Commission on Domestic Violence Fatality Review Board, whose research helped pass increased protection for domestic violence victims. The Republican Party chose her as its candidate for New York State Attorney General in 2006.

Pirro earned a BA from the University of Buffalo and received her Juris Doctor law degree from Albany Law School.

Judge Jeanine Pirro will receive the 2019 St. Barnabas Hance Award for her loyalty, conviction and compassion—characteristics that compelled St. Barnabas founder Gouverneur Hance to care for Pittsburgh’s poverty stricken in 1900.
